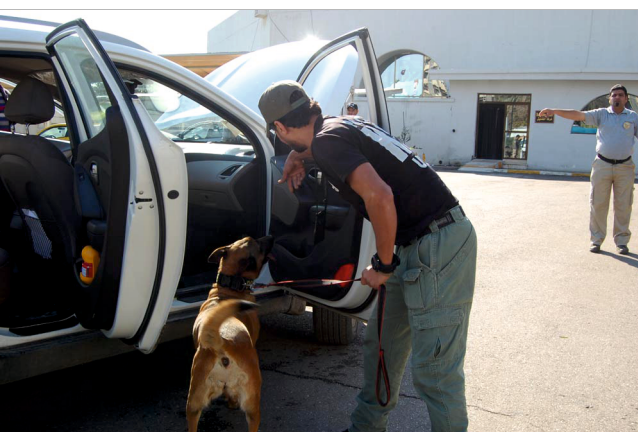

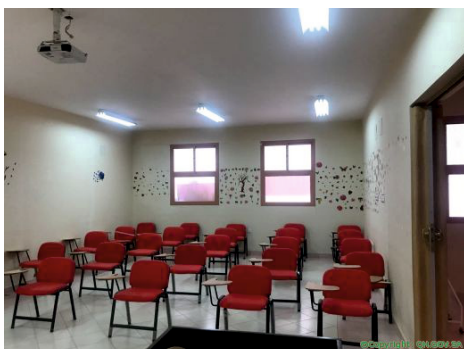

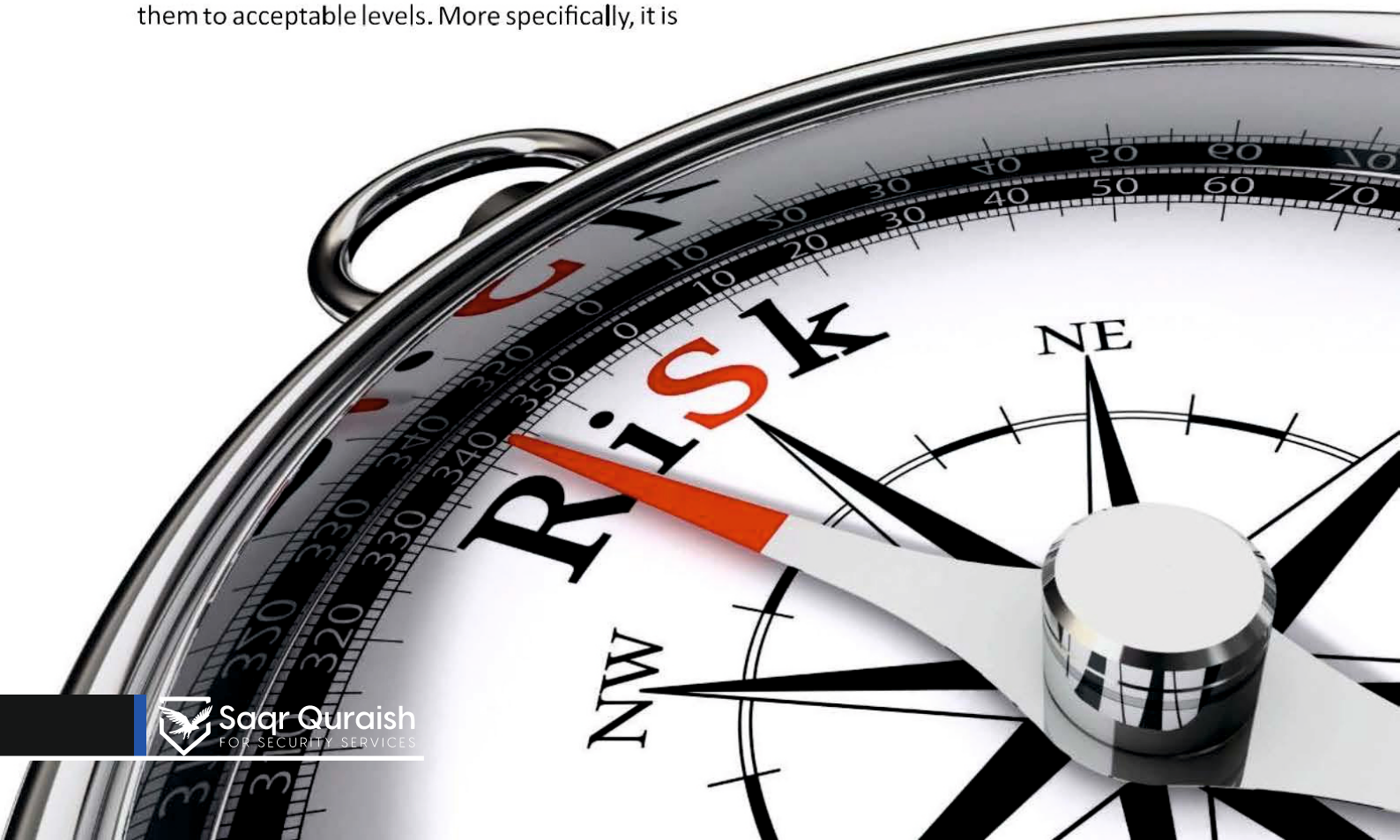
RISK MANAGEMENT

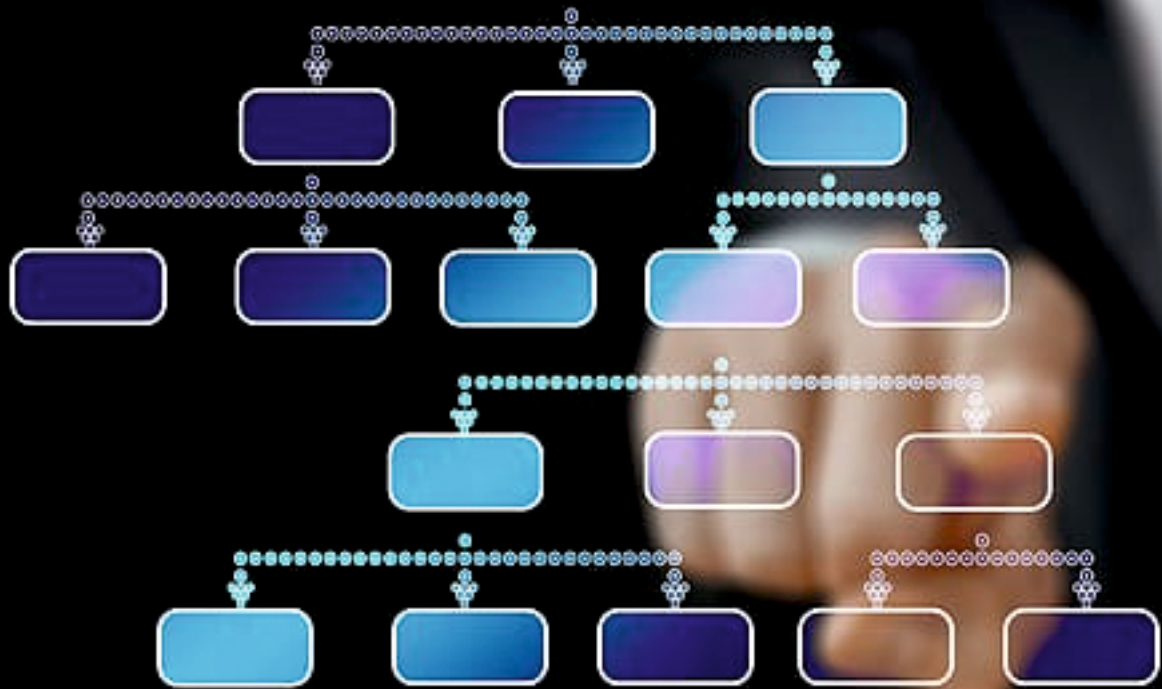

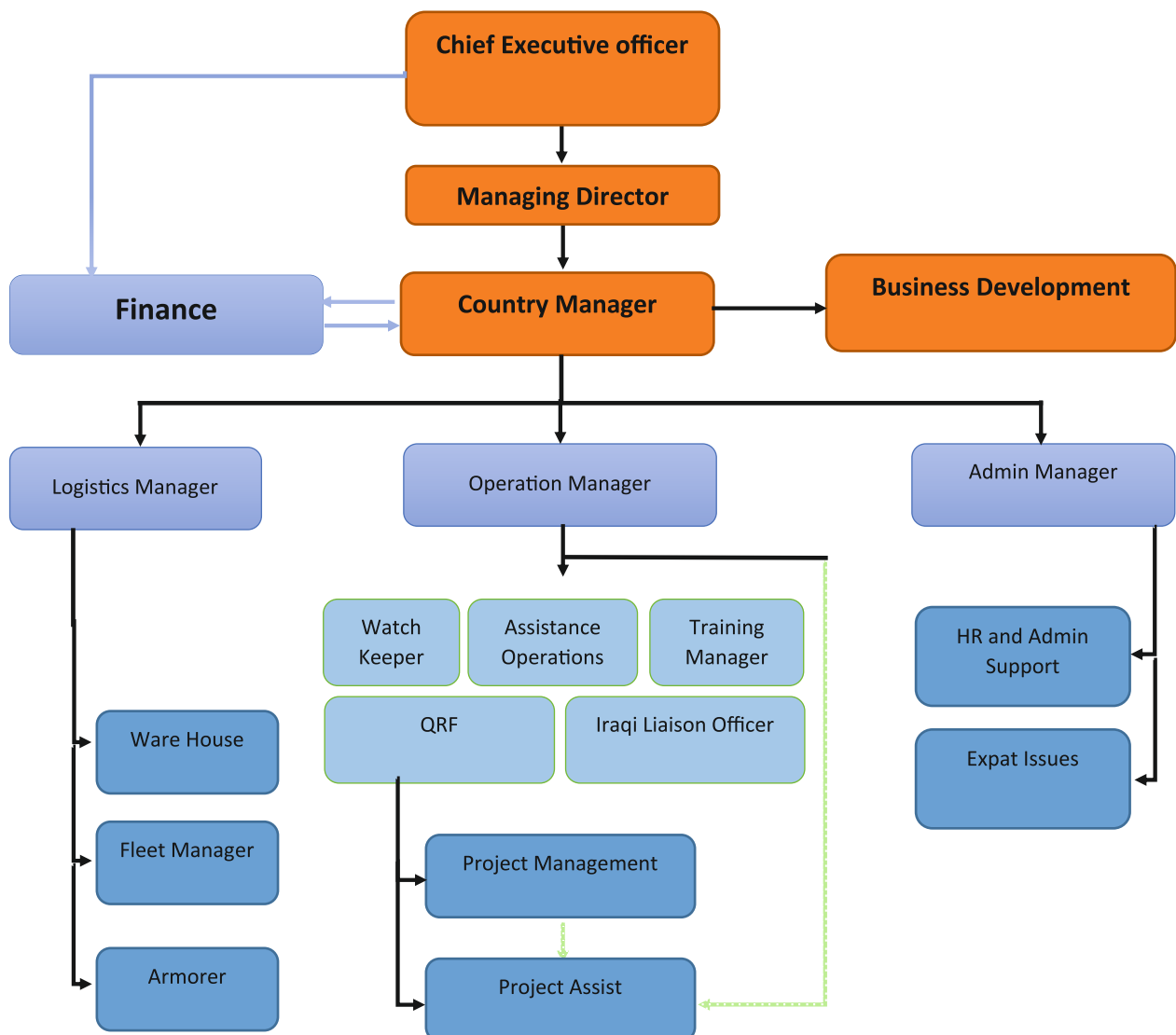

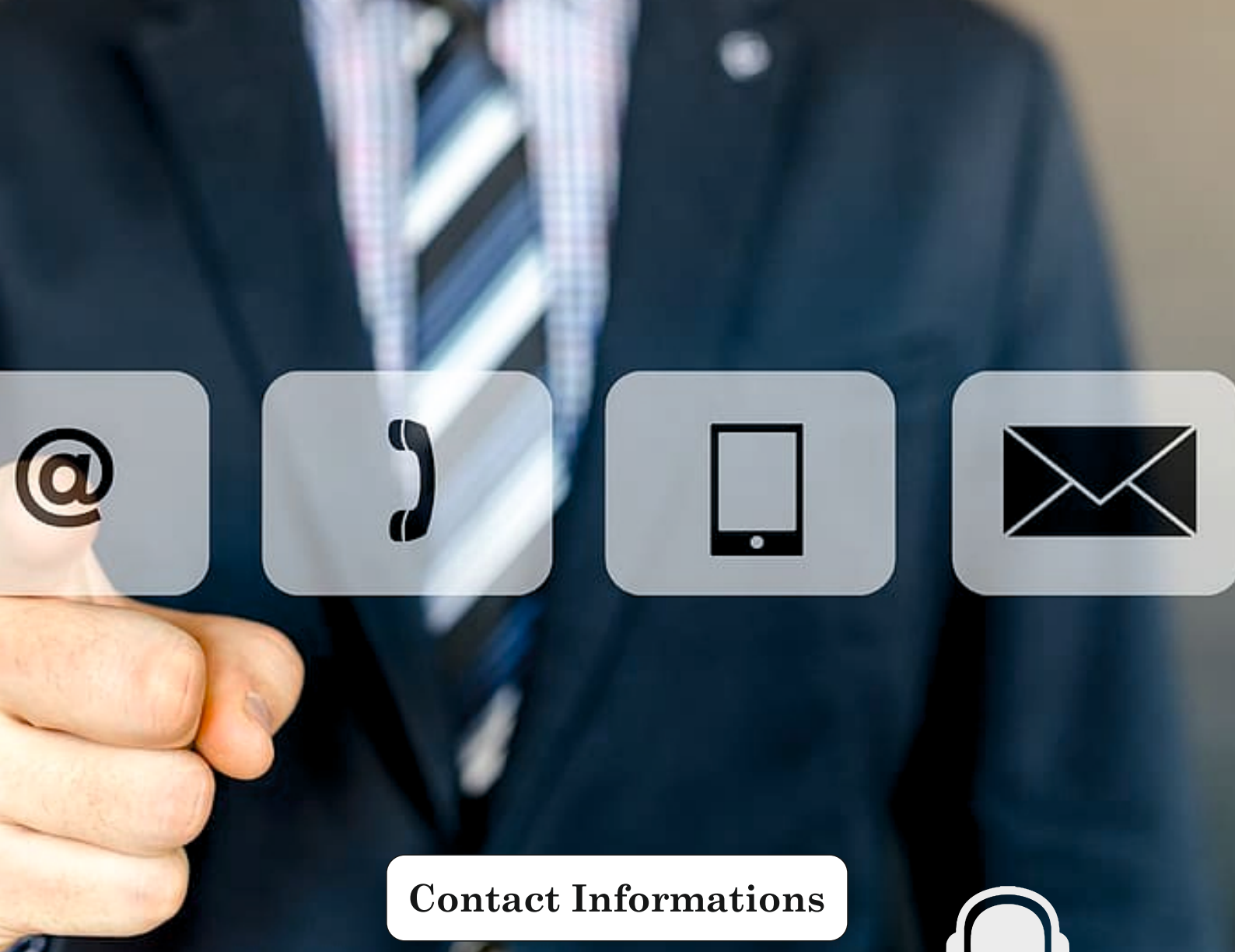
Company Structure



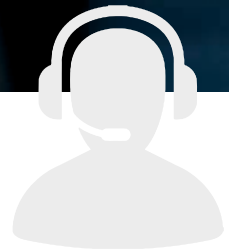


Distances from important locations
